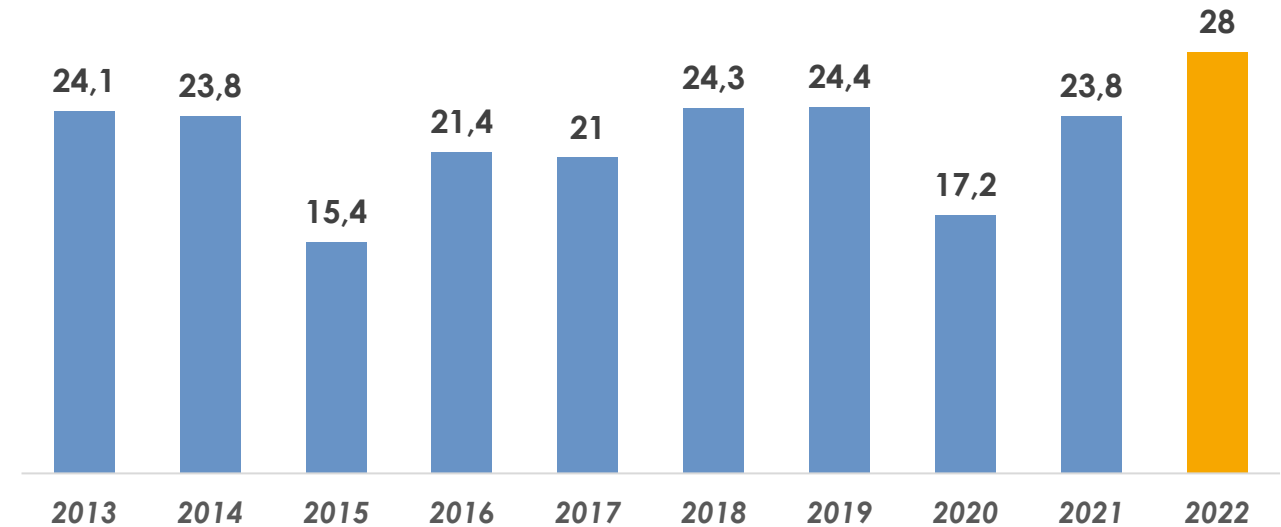
BY FDI IN CENTRAL ASIA (61%)

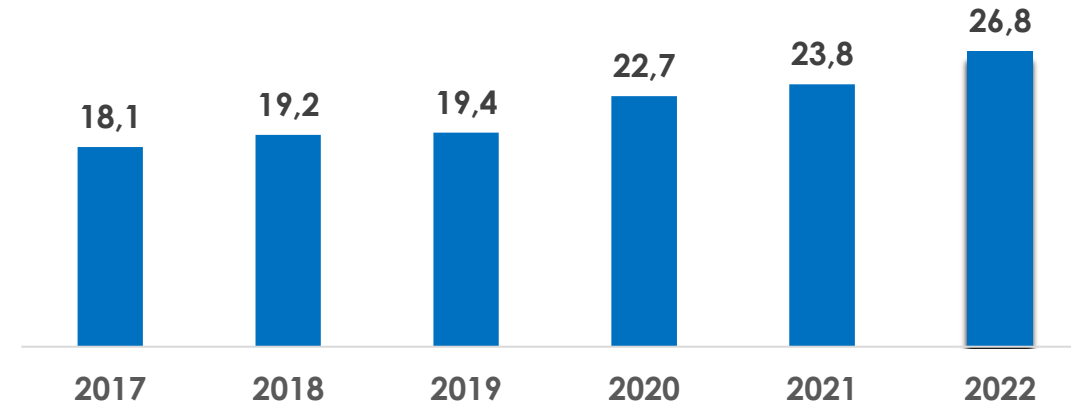

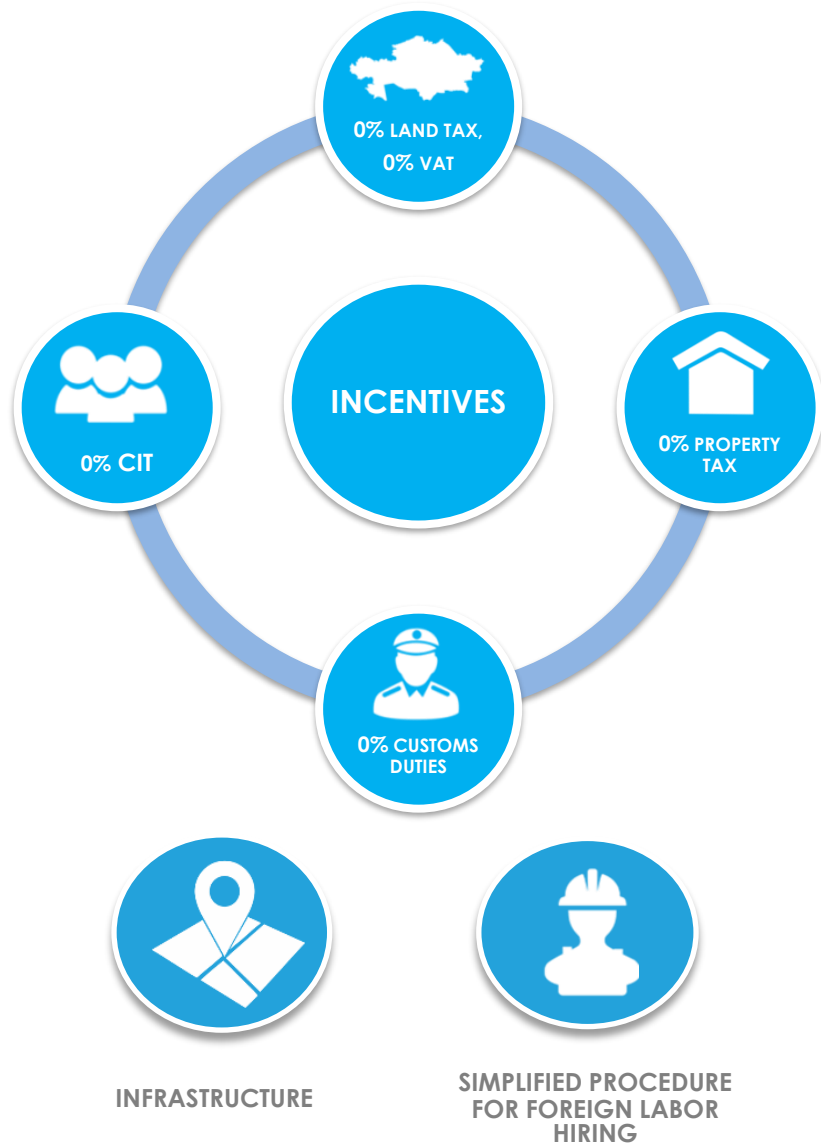

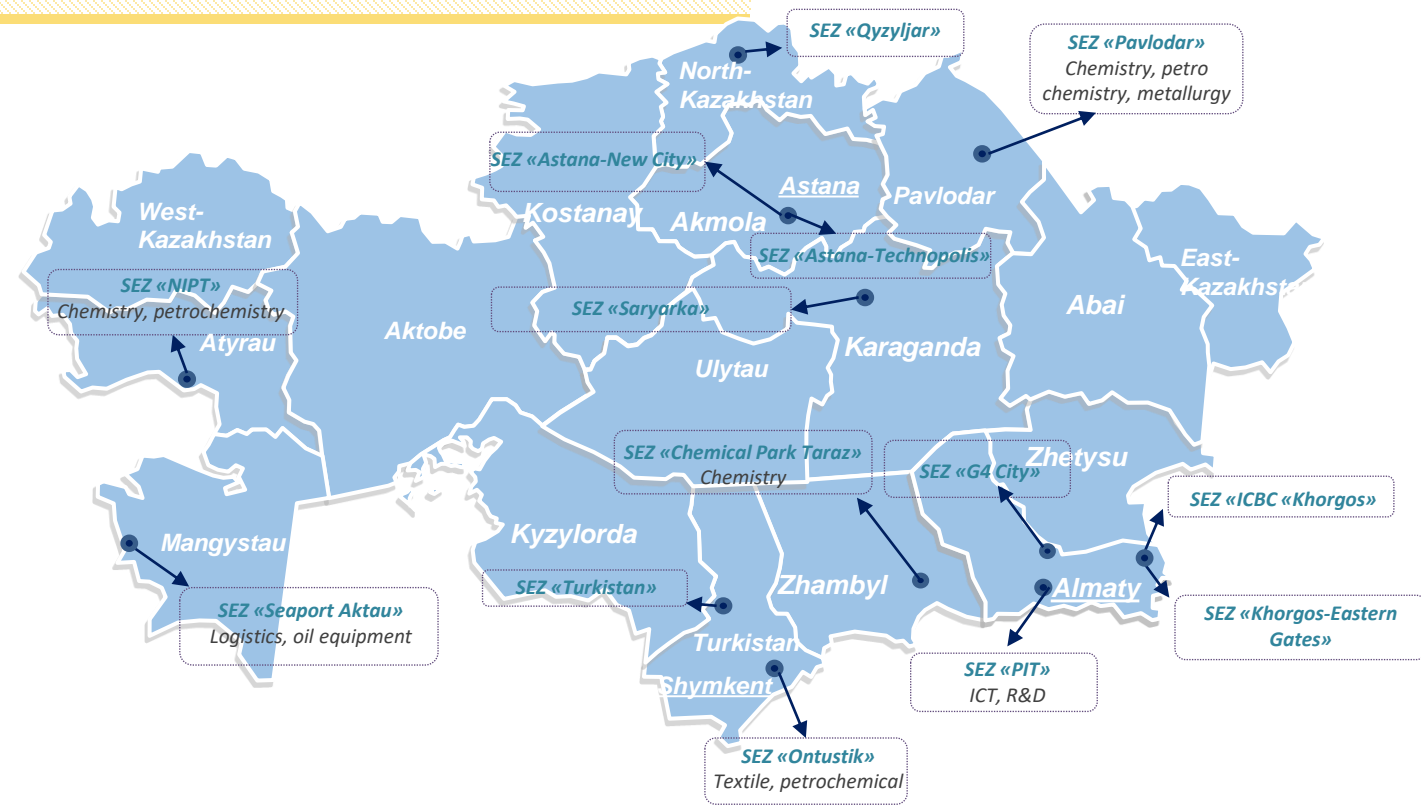
